VOLUNTEER SERVICE AGREEMENT

If I am chosen or elected to serve as a member of the Board of Directors of First General Credit Union, I agree to conform to and abide by the following:

- 1. Attend all regular and special meetings and planning sessions when notified unless prevented in attending by circumstances beyond my control.**
- 2. Actively participate in one or more committees as assigned.**
- 3. Seek to learn more about the credit union movement, First General Credit Union and its services and about my individual responsibilities.**
- 4. Consider the business of the credit union and its members to be confidential in nature and not to discuss such business inappropriately.**
- 5. Should I ever find myself under obligation to any other group or organization that is in conflict with the credit union, I shall disclose the conflict to the Board Chairman and refrain from voting or acting on issues related to the conflict.**
- 6. Participate to the best of my ability in determination of policy and other matters. Give full attention to problems of the credit union, and vote on issues submitted or proposed for action.**
- 7. Give all support possible to my fellow Volunteer Officials and Management of the credit union.**

I fully understand that failure to fulfill the duties and responsibilities to the credit union under the terms of this agreement, the bylaws and policies of the credit union, the Michigan Credit Union Act and the National Credit Union Administration Rules and Regulations may cause dismissal as a volunteer and may cause me to be personally liable. Should I not be able to fulfill my official obligations, I will offer my resignation. I certify also that I am current on all outstanding obligations and have met the minimum requirements to serve as set forth in the Michigan Credit Union Act. The credit union is hereby authorized to obtain a commercial or consumer report on my credit history and seek whatever information is necessary for completing a background investigation of me.
